Fit the cups over the ears, with the marking "TOP" above the ear

Slide headband down until it touches the top of the head

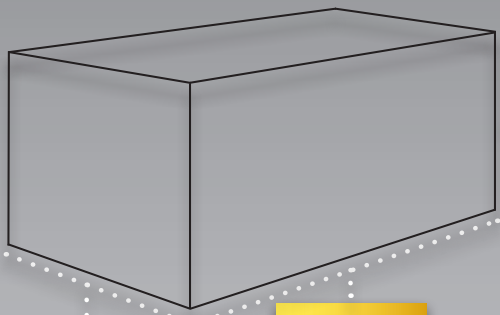

LIMITATIONS OF USE

Protection will only be offered if the ear defender is fitted correctly

Ear pads may deteriorate with use and should be examined at frequent intervals

The pads are available as a spare part

Do not apply paint, solvents, adhesives or self-adhesive labels, except in accordance with instructions from the manufacturer

The ear pads, when in contact with the skin may cause allergic reactions to susceptible individuals

If this occurs leave the hazard area, remove the ear defender and seek medical advice

If the ear defender is to be worn for long periods the noise level must be reduced to 80dB

Before selection of a suitable ear defender a noise survey should be carried out

Spectacle frames and hair between the ear pads and the head may affect the performance of the ear defender

Hearing Protection should be used in accordance with the European Physical Agents (Noise) Directive 2003/10/EC
