Description of the PPE:

JACKET: FRONT ASSEMBLY: two components fastening centrally with an acetate zip with metal pull covered by hems. SLEEVES: long shirt-type. The cuffs have a storm cuff in black elasticated knitted fabric. COLLAR: rectangular double layer of fabric, fastening with the central zip and hems. BACK: straight. WAISTBAND: in black elasticated knitted fabric. POCKETS: Patch pocket with flap fastened with self-fastening tape: two interior. Large pocket with flap: one at the waist each side. Large open pocket: one at the waist each side. TROUSERS: FRONT LEGS: two components with bib, elasticated braces and acetate buckles. Closing at the front with the fly which fastens with an acetate zip and metal pull covered by hems. The trouser bottoms adjust with a zip. WAISTBAND: double layer of fabric with elasticated tape. BACKS: two components joined at the seat. POCKETS: French pocket: one at the hip each side.

The materials that form the PPE, are described in the technical report nº 2019EP3415UE.

It shall be the manufacturer's responsibility to provide specific information of this certificate and the tested levels of protection.
