## Performance and Limitation of use:

Do not use for handling objects exceeding the temperature of 50°C, liquid or chemical products. Conformity according to EN 381-7:2001 protective gloves for users of hand-held chainsaws. The glove should be discarded and not used again if the protective area on the left-hand glove has been damaged, washed, cleaned, or altered from its original shape. 
